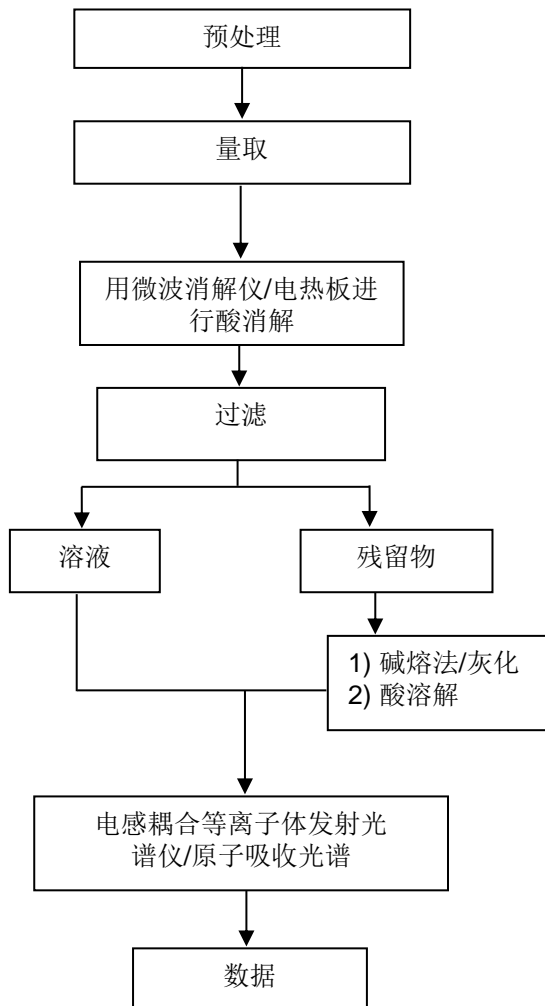

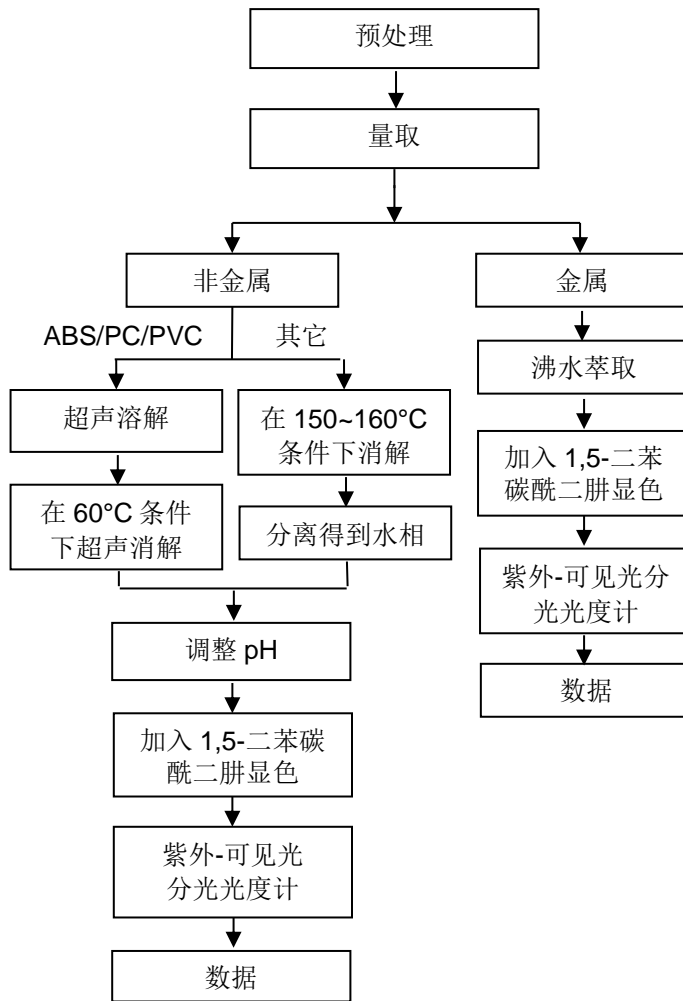

六价铬检测流程图

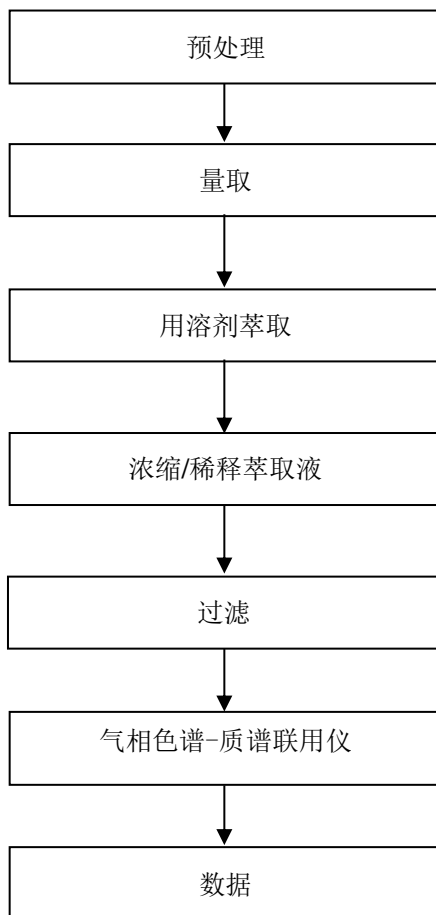

PBBs/PBDEs 检测流程图



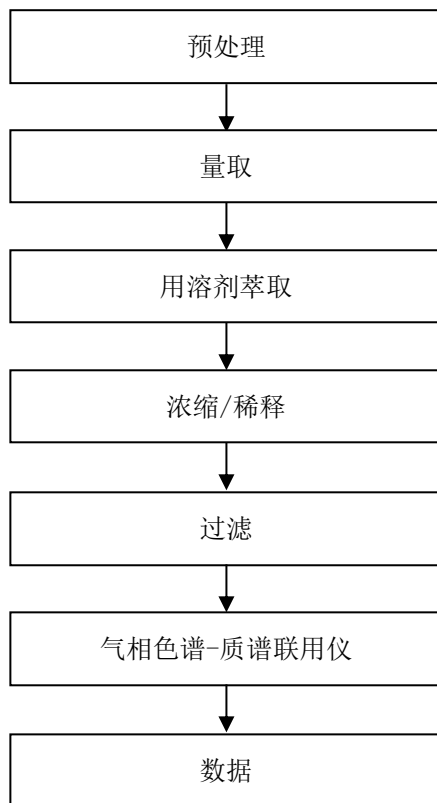
